# The Board of Trustees approved at its meeting of December 14, 2012 the following items effective Fall 2013:

## **DEPARTMENT NAME CHANGE**

Pending approval, a change in department name is suggested. In a Department of Art Faculty Meeting on October 26<sup>th</sup>, 2007, members voted unanimously (7-0-0) to change the name of the department to "The Department of Art and Design". The discussion that preceded this vote noted that this change was a reflection of the current curriculum offered by the department and mirrored the name of our accrediting organization, the National Schools of Art and Design (NASAD). The addition of "Design" to our name is additionally one shared by many colleges and universities in and outside of Indiana. Perhaps most importantly, the change will better communicate to future students what the Department of Art provides. The Graphic Design concentrations of the Art degrees have the highest enrollments of all the concentrations.

The schools listed below all have Departments of Art & Design. Curricular options in each department are comparable to our program (Graphic Design, 2-D Studio, 3-D Studio).

#### **COLLEGE OF ARTS AND SCIENCES: Interdisciplinary Programs**

#### Multidisciplinary Studies Minor (21 hours) CIP Code: 240101 Major Code:

#### **Brief Summary:**

Multidisciplinary Studies proposes to add a minor in Multidisciplinary Studies. This minor will allow students to design their own course of study at the level of a minor, and encouraging them to pursue a coherent but idiosyncratic field of study as a complement to their major field of study. This minor also can serve as the location for incubation of new interdisciplinary minors by faculty, allowing for new areas of study to be developed and offered without committing at the outset to the formal development of the minor. Once student interest has been demonstrated, these minors can apply with confidence for separate and permanent status in Multidisciplinary Programs.

#### **Student Learning:**

The university is encouraging students to complete minors to enhance their major fields of study, and provide additional focus to their overall degree progress. This minor allows students to access the diverse resources of the university in ways which serve their needs, and still provide that structure. This minor will be even more useful to the faculty, however, who are looking to innovate within the curriculum. It will encourage them to attempt interdisciplinary collaboration and curriculum (a goal in the College of Arts and Sciences strategic plan) but offering a low stakes approach.

#### **Proposed Catalog Copy:**

#### Multidisciplinary Studies Minor (21 hours) CIP Code: 240101 Major Code:

The Multidisciplinary Studies minor allows students to pursue a coherent, multidisciplinary course of study not duplicated by any existing ISU minor. It encourages students to engage in focused exploration of related disciplines in their areas of interest or in fields which complement their declared major. Students may design their own minor or, when available, select from multidisciplinary minors already developed by faculty.

#### **Required course (3 hours):**

MST 401: Seminar in Multidisciplinary Studies (prerequisite senior standing)

#### **Elective courses (18 hours):**

Students submit a proposal to the intake adviser for Multidisciplinary Studies, which will be approved by a vote of the faculty in Multidisciplinary Studies. Once the proposal is approved, those courses constitute the approved list for the minor. Votes take place once per semester, in November for the fall and in March for the spring.

#### Additional requirements:

At least 9 of the 18 hours must come from the College of Arts and Sciences. At least 12 of the 18 hours must be at the 300 level or above. A maximum of 9 hours can come from any one discipline. *Effective term: Spring 2013*

# COLLEGE OF NURSING, HEALTH, AND HUMAN SERVICES: Applied Medicine and Rehabilitation

#### **Brief Summary:**

The accrediting body of the American Occupational Therapy Association (ACOTE) has updated the Standards for Masters Entry Level Programs. In order to meet these new standards and to keep current with contextual changes in the profession, the following changes are requested:

Update admissions requirements to increase consistency with other MSOT programs.

- 1. In addition to completing an application form for University College of Graduate Studies, prospective applicants will also be required to complete an application specifically for Occupational Therapy.
- 2. Increase number of recommendations on the entry application to include a health care provider, an academic advisor or course instructor, and a community service experience supervisor.
- 3. Add a Community Service Experience Component to the pre-requisites for the program, totaling 40 hours.
- 4. Add verification of Computer Competency to the program application.

Add to Prerequisite Coursework:

- Introductory Psychology (3 credit hours): Equivalent of ISU PSY 101 General Psychology
- Abnormal Psychology (3 credit hours): Equivalent of ISU PSY 368 Introduction to Abnormal Psychology
- Introductory Sociology or Anthropology (3 credit hours): Equivalent of ISU SOC 101 Introduction to Sociology

Delete:

• Physics (3 credit hours minimum)

Change Prerequisite Coursework to:

• Developmental Psychology (3 credit hours) \* Course must cover the Life Span: Equivalent of ISU EPSY 221 Developmental Psychology, or ISU PSY 266 Developmental Psychology

#### **Student Learning:**

The above changes in the Occupational Therapy Program Pre-requisites are required to meet the updated accreditation standards set forth by the ACOTE (Accreditation Council for Occupational Therapy Education) (2012).

ACOTE Accreditation Standards / Foundational Content Requirements:

A.4.3 The program's accreditation status and the name, address, and telephone number of ACOTE must be published in all the following materials used by the institution: catalog, Web site, and program-related brochures or flyers available to prospective students.

B.1.2. Demonstrate knowledge and understanding of human development throughout the lifespan (infants, children, adolescents, adults, and older adults). Course content must include, but is not limited to, developmental psychology.

B.1.3. Demonstrate knowledge and understanding of the concepts of human behavior to include the behavioral sciences, social sciences, and occupational science. Course content must include, but is not limited to introductory psychology, abnormal psychology, and introductory sociology or introductory anthropology.

*B.1.4.* Apply knowledge of the role of sociocultural, socioeconomic, and diversity factors and lifestyle choices in contemporary society to meet the needs of individuals and communities. Course content must include, but is not limited to, introductory psychology, abnormal psychology, and introductory sociology or introductory anthropology.

The requested change will meet the standards listed above. The other changes are consistent with the admissions requirements for similar Masters Entry Level Occupational Therapy Programs.

- Bachelor's degree from a four (4) year accredited university with a cumulative and

prerequisite grade point average (GPA) of 3.0 on a 4.0 scale. The baccalaureate degree must be earned before enrolling into the program and can be in any field. All coursework must be completed within the past seven (7) years.

- Three (3) professional recommendations.
- GRE score
- TOEFL above 550
- Community Service Experience totaling 40 hours
