Please note that the following course was initially published in the February 14, 2000 issue of *Academic Notes* as a NEW COURSE PROPOSAL. Demonstrations and directed laboratory experiences focus on diagnostic tests commonly encountered in primary health care settings. The appropriate preparation and interpretation of screening procedures for the management of chronic and acute illnesses presented throughout the family nurse practitioner curriculum will be included. To be taken concurrently with 644 or consent of instructor.
