### **EXECUTIVE SUMMARY:**

The School Nursing Curriculum and Academic Affairs Committee is recommending that students admitted to the Associate Degree Nursing Program prior to Fall Semester 2000 be permitted to select either Chemistry 100/100L or Chemistry 104/104L. Students admitted Spring Semester 2000 were the last students admitted under the previous Associate Degree Curriculum. The University Curriculum and Academic Affairs Committee (CAAC) approved Chemistry 100/100L in the curricula for the modified Baccalaureate Nursing Program during the 1998-1999 academic year and for the revised stand-alone Associate Degree Nursing Program during the 1999-2000 academic year. Approval of this proposal will not necessitate any change in catalog copy as the curriculum for the stand-alone Associate Degree Program is published in the *Undergraduate Catalog* 2000-2002.

### **RATIONALE:**

The requested modification of the Chemistry requirement would provide consistency in Chemistry requirements for all students enrolled in the Associate Degree Nursing Program. This proposed change potentially would reduce the total credit hours that students must take by four credits since Chemistry 103/103L is a prerequisite for Chemistry 104/104 and the majority of students are not successful challenging Chemistry 103/103L. The result is that most of the Associate Degree Nursing

students admitted prior to Fall 2000 complete eight hours of Chemistry rather than the four credits required for students enrolled in other Undergraduate Nursing Programs. Dr. Arthur Halpern, Chairperson of the Chemistry Department, has been contacted regarding this proposal. He stated verbally that he has no objection to the proposal.

# **NEW COURSES**

### **COLLEGE OF ARTS & SCIENCES: African & African American Studies**

### MA in English, MA/MS in English for Teacher Licensure

### **ABSTRACT:**

The MA in English, MA/MS in English for Teacher Licensure offers graduate work in English for students in, or expecting to enter, such fields as teaching and writing, editing, publishing, and curric-

ular supervision. Both programs require a minimum of 32 hours including a core of 6 hours (two 600-level courses) in research and theory, a 9 hour (three 600-level courses) English core, a minimum of 11 hours of electives for specialization in either Literature or Writing, 6 hours of study outside the area of specialization (may be outside the department), and a culminating experience consisting of a Master's paper or a thesis. Candidates for the MA degrees must demonstrate reading knowledge of one classical or modern language.

### **RATIONALE:**

The proposed change affects the English core requirements. Currently students are required to take a 600-level course in each of the following areas: English literature, American literature, and English language/linguistics or rhetoric/composition. The change would require them to take 600-level courses in English literature before 1800, English literature after 1800, and in American literature. This core would give our students broader coverage in literature, and better prepare them for teaching, creative writing, and advanced graduate study, which has become more necessary for professional advancement and success in English studies. The change would also bring our programs' requirements more in line with those of MA programs in English at other schools, which typically specify coursework in the literature of several historical periods and genres. Also, with the movement of the linguistics faculty and program to the Department of Foreign Languages and Literatures, courses in language/linguistics will be taught outside the Department of English and could no longer be considered part of the English core. English graduate students who choose to take such classes may count them as electives outside the area of specialization. ### **Community Health Major**

### **EXECUTIVE SUMMARY:**

The Community Health program proposes to make minor changes to its major and foundation course offerings, based mainly on changes in personnel. In the foundation block, the changes consist of deleting two of the five anatomy/physiology options; deleting one of the two personality psychology options; and adding a 2.0 hour fitness education requirement. These changes result in adding 2.0 hours to the foundation block, from 17-19 hours to 19-20 hours.

In the major block of classes, the changes consist of substituting lower-division courses for upperdivision equivalents in environmental health and safety, and requiring students to complete both courses rather than just one; and, replacing both of the 3.0 hour, specialized peer-health-facilitation courses with one 1.0 hour, generalized course. These changes result in adding 3.0 hours to the major, from 45 hours to 48 hours.

In sum, these proposed changes result in increasing the total program from 62-64 hours.

#### **RATIONALE:**

The proposed changes will provide majors with a basic fitness course; increase the number of sophomore-level courses; provide students with an introduction to both environmental health and safety; and, eliminate courses from the major that seem unlikely to be offered in the foreseeable future.
