FACULTY SENATE EXECUTIVE COMMITTEE REPORT FOR DECEMBER 5, 2000

The Faculty Senate Executive Committee met at 3:15 p.m. in the Hulman Memorial Student Union (HMSU), Room 227.

President Benjamin reported on his investigation of "service learning" opportunities for students, on planned presidential inauguration activities, and on the activities surrounding the opening of the Student Art exhibit.

Interim Provost Hopkins updated the Committee on the ongoing study of financial aid concerns, the Blue Ribbon Study Committee on Distance Education, and on upcoming meetings of separate study groups considering salary compression and temporary faculty policies.

He noted that nominations for the Caleb Mills, Faculty Distinguished Service, and Dreiser Distinguished Research/Creativity awards are due December 15 and he asked that faculty be encouraged to apply or make nominations.

Chair Bell reported on the recent Health Fair and on progress in moving the Grievance Policy document toward completion. He indicated that he expected the document to be ready for presentation to the Trustees at their February meeting.

In response to questions, Hopkins explained that adjustments to travel policies were being addressed by the Administrative Affairs Committee, an analysis of travel allocations was in the works, and that the University would be filling the position of Curator of the Permanent Collection. The Committee also discussed campus safety.
