# FACULTY SENATE EXECUTIVE COMMITTEE REPORT FOR APRIL 17, 2001

The Faculty Senate Executive Committee met at 3:15 p.m. in the Hulman Memorial Student Union (HMSU), Room 227.

President Benjamin explained details of the upcoming HR survey, noting that he expected a complete report in mid May. He also updated the Committee on budget prospects.

Interim Provost Hopkins noted the deadlines for applications for the positions of General Ed. Coordinator and Interim Dean of Arts and Sciences, and his pleasure at attending the Verizon Athletics Banquet.

Chair Bell announced the officers of the Faculty Senate for 2001-02: J. Cerny (Chair), S. Lamb (Vice Chair), C. Hoffman (Secretary), and reminded members that a Public Access seminar will take place 4/27.

The 15-minute open discussion period addressed appeals of salary recommendations (last year's procedures will apply), and reallocation of funds within the academic units (each unit has autonomy in reaching its goal, but student help funds will not be reallocated).

The Committee approved the following curriculum proposals:

- (1) Anthropology 100 (as amended),
- (2) Education Praxis II exam,
- (3) Math 102 (revised),
- (4) BA Foreign Language requirement reduction from 14 to 12 hours,
- (5) School of Nursing program revisions (3): BSN Degree, BSN Track for those entering with an RN, Associate Degree Program.

The Committee approved the following FEBC recommendations:

- (1) Dependent child fee waivers of \$1200 per semester, pro-rated for part-time undergraduates,
- (2) Fee reduction equivalent to one-half in-state fees for spouses of regular full-time faculty,
- (3) Parking tags for non-tenure-track faculty at the same rate as support staff,
- (4) Cash provision for withdrawal of 10% of TIAA-CREF funds, and
- (5) Reaffirmed the 11/30/99 FEBC recommendation that: "full-time temporary faculty be compensated at a rate of no less than \$24,000/year...[and] part-time faculty be compensated at a rate of no less than \$1000/credit hour...."

The Committee also addressed a question of procedure under the Constitution of the School of Technology and directed the Secretary to summarize and convey the Committee's conclusions.
