2002 CALEB MILLS DISTINGUISHED TEACHING AWARDS

Nominations for the 2002 Caleb Mills Teaching Awards are now being solicited. A maximum of four awards will be presented during the spring commencement ceremony.

To be eligible for this award, the nominee must be a full-time tenured faculty member who is teaching a minimum of 16 semester hours or 24 contact hours at ISU during the preceding summer, fall, and spring semesters of the current academic year.

Full-time faculty, students, alumni, or administrators may submit nominations. Submissions must include a completed Nomination Form, and a statement on why you believe this nominee should be selected as one of ISU's best teachers, which includes specific examples and/or documents regarding the faculty member's qualities.

2002 FACULTY DISTINGUISHED SERVICE AWARDS

Nominations for the 2002 Faculty Distinguished Service Awards are now being solicited. A maximum of two awards will be presented during the spring commencement ceremony in May.

To be eligible for this award, the nominee must be a tenured faculty member who has demonstrated service while at Indiana State University in the form of: membership in faculty government at the college/school or University level; membership on committees within the University; service to student organizations; service to professional organizations; and service to community groups.

FACULTY GOVERNMENT

FACULTY SENATE EXECUTIVE COMMITTEE REPORT FOR OCTOBER 30, 2001

The Executive Committee met at 3:15 p.m. in Hulman Memorial Student Union (HMSU), Room 227.

Provost Pontius distributed draft copy of the Program Array Review (PAR) committee recommendations and the CHRONICLE ad for 56 available ISU tenure-track positions. He noted that performance-based-pay criteria this year are the same as those developed for the last performance-based evaluation (two years ago), and that the proposed configuration for the Graduate School/Graduate Dean would come to the Executive Committee prior to a position announcement in the CHRONICLE before Thanksgiving. He will request faculty nominees for the search from the Senate Administrative Affairs Committee.

The provost distributed copies of the Charge to the President's Blue Ribbon Committee on Distance Education, the Distance Education Guidelines for Program/Course Transformation and Delivery, the Intellectual Property Policy, and the Proposed Policy Statement on the Administration of Undergraduate Certificate Programs.

Chair Cerny reported on his work with P. Carino to encourage greater faculty participation in the Faculty Scholarship Fund, continuing research into the student appeals process, a status report from the General Education Committee, and on a voting rights/speaking seats inquiry about non-tenure-track members on search committees. Provost Pontius said he would "entertain recommendations for appropriate stipends" for non-tenure-track members of such committees.

The 15-minute discussion period addressed the 12/15 deadline for the Blue Ribbon Distance Education report and concerns about Student Credit Hour (SCH) targets and their implementation. The provost stressed that SCH targets are a "work in progress" to be implemented over a two-year *FACULTY GOVERNMENT – Faculty Senate Executive Committee Report: continued*

period, and that the targets would be integrated with a workload policy. He noted that the teaching component must always come first. Also discussed was a funding shortfall in the ISU Writing Center. The provost indicated a willingness to respond favorably to a funding request from the director of the Center.

The Committee approved the following curricular proposals:

- 1) CIMT Professional Educ. Sequence for All-Grade Education (as amended)
- 2) CIMT Professional Educ. Sequence for Senior High-Junior High/Middle School Education
- 3) Political Science Legal Studies Minor
- 4) LLL Full Languages, Literatures, and Linguistics Program
- 5) General Ed: LLL German 308 Soc. 302

The Committee accepted the following items for action by the Faculty Senate:

- 1) School of Business constitutional revision
- 2) Reaffirmation of the statement on emeriti faculty accommodation
- 3) Request for a survey of faculty retirees concerning "what they would find helpful in continuing meaningful involvement in the University."

The Committee accepted the Evaluation Criteria Recommendations of the Program Array Review Committee and directed that it be distributed to departments and faculty. Committee members and Provost Pontius expressed their appreciation for the work of the PAR committee.

The Committee selected tenure-track faculty representatives to the President's Effectiveness Steering Committee, noting that it would select non-tenure-track representatives after an appropriate stipend had been established.
