THEODORE DREISER DISTINGUISHED RESEARCH/ CREATIVITY AWARDS

The Theodore Dreiser Distinguished Research/Creativity Award recognizes work substantially completed at Indiana State University by regular, full-time members of the university faculty who have made outstanding contributions to their disciplines. Work completed to satisfy advanced degree requirements is not eligible for consideration. As many as two awards, consisting of a monetary award and a plaque, may be given each year. Faculty members who have previously received the award are ineligible for consideration for a four-year period. Faculty are encouraged to nominate eligible colleagues. Self-nominations will also be accepted. Nominations may be in letter or memo format and should be

2002 CALEB MILLS DISTINGUISHED TEACHING AWARDS

Nominations for the 2002 Caleb Mills Teaching Awards are now being solicited. A maximum of four awards will be presented during the spring commencement ceremony.

To be eligible for this award, the nominee must be a full-time tenured faculty member who is teaching a minimum of 16 semester hours or 24 contact hours at ISU during the preceding summer, fall, and spring semesters of the current academic year.

Full-time faculty, students, alumni, or administrators may submit nominations. Submissions must include a completed Nomination Form, and a statement on why you believe this nominee should be selected as one of ISU's best teachers, which includes specific examples and/or documents regarding the faculty member's qualities.

Faculty members are encouraged to nominate eligible colleagues. Nomination Forms, which are a 3 x 5 printed card, are available in the academic departments and the deans' offices. Additional nomination cards can be obtained in the Center for Teaching and Learning or by calling extension 8363.

2002 FACULTY DISTINGUISHED SERVICE AWARDS

Nominations for the 2002 Faculty Distinguished Service Awards are now being solicited. A maximum of two awards will be presented during the spring commencement ceremony in May.

To be eligible for this award, the nominee must be a tenured faculty member who has demonstrated service while at Indiana State University in the form of: membership in faculty government at the college/school or University level; membership on committees within the University; service to student organizations; service to professional organizations; and service to community groups.

Full-time ISU faculty, students, alumni, administrators, and citizens of the Wabash Valley may submit nominations. Submissions must include a completed Nomination Form, a letter or statement on why you believe this nominee should be the recipient of a Faculty Distinguished Service Award and the names, addresses, and phone numbers of three to five individuals who can testify to the nominee's service.

FACULTY GOVERNMENT

FACULTY SENATE EXECUTIVE COMMITTEE REPORT FOR NOVEMBER 27, 2001

Provost Pontius reported that he expects reports soon from special committees considering summer school issues and the status of chairs. He discussed budget issues, a request from SGA for advance availability of course syllabi, the upcoming search for a Dean of the School of Graduate Studies, the status of undergraduate certificate programs, progress regarding Student Learning outcomes, a complimentary report from the Lilly Foundation, and a need for clear definition of "program" and "department."

Chair Cerny noted that grievance pool training would be conducted 12/6, that budget discussions had occurred at the recent deans' council meeting, and that he was gratified to learn full budget information will be shared with the University community. He addressed the SGA proposal to make advance course descriptions available, indicating that one goal is to reduce the number of drops and adds at the beginning of terms.

He also recognized the naming of Mary Johnson of the T.H. Center for Medical Education as Indiana Professor of the Year by the Council for Advancement and Support of Education, in collaboration with the Carnegie Foundation.

The Committee discussed:

1) Desirability of performance-based pay with limited funds

Members noted that the Senate, in prior years, had approved merit pay only after a cost-of-living increment, that the system involved laborious, rigorous, and time-consuming evaluation, that the budget situation is expected to provide too little money to permit meaningful awards, and that, if pursued under current conditions, the process is likely to have a negative impact on morale. The provost said he would like to distinguish between "review" and "pay," noting that "review" should be on-going.

2) Compression adjustments

The provost reported that, in the five-year Academic Affairs budget plan, \$100K + fringe benefits had been designated for compression adjustments in each of the next two years. The decision to continue funding compression, however, depends on the availability of dollars in the developing budget. Priorities for distribution of available funds will be set in January.

- 4) Forwarding to Administrative Affairs Committee a suggestion to institute a faculty survey which would be repeated at a regular interval.

The Committee tabled (for clarification): Search Committee nominees for VP Student Affairs and Dean of Students.

The Committee went into executive session to discuss grievances.

The Committee came out of executive session and voted to forward a grievance to FAC for a hearing.
