COURSE REVISIONS

COLLEGE OF EDUCATION: Counseling

SAHE 738 [Professional Seminar: Student Affairs and Higher Education--3 hours. This course is an exploration of leadership and management issues in Student Affairs and Higher Education. Topics include leadership, organizational models, management practice and theory, human resource management, fiscal resource management, current professional issues, professional and personal development, professional ethics and legal issues.]

Change number and description to:

SAHE 680 [Professional Seminar: Student Affairs and Higher Education--3 hours. This course is the culminating experience for the master's degree in Student Affairs and Higher Education. Topics include current professional issues, professional and personal development, and professional ethics.]

Preferred Effective Term: Fall 2005

COURSE REVISIONS

COLLEGE OF ARTS AND SCIENCES: Political Science

PA 609 Ethical Concerns in Current American Public Administration--3 hours. Ethical problems and concerns for public administrators, as these are being raised and framed by the National Association of Schools of Public Affairs and Administration (NASPAA). Survey of the work of leading authors closely connected with the evolving NASPAA ethics project. A major research paper will be required.

Change description to:

PA 609 Ethical Concerns in Current American Public Administration--3 hours. This course reviews theories of ethics and principles of ethics applied to management in the public sector. It deals with ethical issues that may confront the public manager. Accountability, discretion, working in the public interest, and influence of public administrators on public policy are reviewed. The course emphasizes practical approaches

to ethical dilemmas in public administration

Preferred Effective Term: Spring 2005 CORRECTIONS: Continued.

PA 697 Research Seminar in Public Administration--3 hours. This course will provide supervised research experience to non-thesis M.P.A. students. Each class member will produce a major research paper and make a formal presentation in an open forum. The class will met regularly to consider methodological innovations, research designs, and progress reports on individual projects.

Change description and title to:

PA 697 Capstone Research Course in Public Administration--3 hours. This is a directed research course that will be taken by each MPA student during her or his final semester in the MPA program. Under the supervision of one or more members of the political science and public administration faculty, students will develop projects suitable for presentation at a public forum. Faculty will judge each project and presentation either as pass or fail. Judgments will be based on form, style, substance, and presentation of each project. Passage of this course is the final step toward the award of the MPA.
