DEPARTMENT NAME CHANGE PROPOSAL

COLLEGE OF EDUCATION

A Proposal to Reorganize the Departments of Communication Disorders, Counseling, and Educational and School Psychology under a new name was approved by the Teacher Education Committee on April 18, 2006, and the Curriculum and Academic Affairs Committee. This proposal will be presented to the Executive Committee of the Faculty Senate in early Fall 2006.

The Departments of Communication Disorders, Counseling, and Educational and School Psychology have a long history in the College of Education. All three areas of study have strong ties to education, health and human services, and rehabilitation. Various programs within the current departments have a

direct link to the process of education and are involved in the direct education of school personnel. In addition, there are direct connections to formal teacher preparation. Finally, all three departments offer practice-based training, service delivery, and outreach. While these areas vary in their relationship with each other, they have a consistent association with education.

This proposal evolved out of a desire to increase educational effectiveness due to changes in the academic environment. It is a continuation of the reorganization within the College that is based on current academic similarity, with regard to education processes, rather than historical perceptions. The education, training, and rehabilitation activities of these three departments outside the traditional K-12 or K-20 system have numerous similarities, and a reorganized department would allow faculty to take advantage of those similarities.

Proposed New Department Name: Communication Disorders, Counseling, School and Educational Psychology.

Courses and programs will remain the same.

Executive Summary:

The department wants to change the Safety Management program from 66 hours to 68 hours. The reasons for the increase are that they are requesting an increase in both the credit and contact hours from 1 to 2 and 2 to 3 hours respectively. The proposed change will enable our students to be more effective in their careers as Safety Managers.

Rationale:

The Industrial Hygiene I and II Laboratories are seeking to have their credit hours increased from 1 to 2 hours as the requested change also increases contact hours from 2 to 3 hours for each course. The proposed change will increase the Safety Management program from 66 to 68 hours. The reasons for increasing the contact and credit hours are as follows:

Industrial Hygiene Laboratory (IH) I & II are core courses in the Safety Management program and for practical preparation of the students for their professional career in the filed of Industrial Safety and Environmental Management.

IH I & II are multi-disciplinary course which require sills in many Occupational Safety and Health Administration's (OSHA) required calculations and field experiments. These OSHA required sampling procedures, calculations, forms, and methods of controls of hazardous materials (e.g., solutions, dusts) variety of experiments in lab and field trips with exhaust ventilation, industrial noise, air sampling, temperature extremes, ionizing and non-ionizing radiation make it very different and much more complicated especially for undergraduates that traditional courses in Physics, Chemistry, Algebra, and Trigonometry. Because all of the topics and skills required for successful completion of this course and more importantly so the students can be successful in their careers as safety professionals.
