NEW COURSE

COLLEGE OF ARTS AND SCIENCES: History

HIST 450 Contested Issues in Democracy—3 hours. This capstone course is designed to synthesize the students' liberal studies program through a focused historical examination of democratic experiences. This capstone course explores how democracy has been conceived and practiced throughout history. We will examine how notions of race, class, religion, and gender have impacted democratic involvement and opportunities. *General Education Credits [GE 2000: Capstone Course]*

NEW COURSES

COLLEGE OF TECHNOLOGY: Industrial Technology Education

ITE 420 Career Development and Employee Appraisals--3 hours. An introduction to the knowledge, tools, skills, and practical methodology needed to apply principles of Career Development. This course is tailored for instructors of adult learners and Human Resource Development Specialists. The class includes career development in the 21st century, understanding and responding to changes in the workplace and family life, career development in cultural contexts, and using standardized tests and inventories in Human Resource Development. *Preferred effective term: Spring 2008*

ITE 425 Organizational Development--3 hours. An introduction to the foundations of organizational development. This course is tailored for instructors of adult learners and human resource development specialists. The class includes the emergence and development of the field of organizational development, the values and ethics underlying organizational development as applied to business practice, and essential skills for the organizational development practitioner.

Preferred effective term: Spring 2008
