## **BOARD OF TRUSTEES**

#### REORGANIZATION OF THE COLLEGE OF TECHNOLOGY

The reorganization of the College of Technology was approved by the Board of Trustees at its September 28, 2007 meeting, as follows:

This request for reorganization is the culmination of over two years of discussions within the College of Technology. On January 12, 2007, at an all-faculty meeting of the College of Technology (COT), after thorough discussion, a vote was taken to reorganize the COT into three departments comprising the areas of aviation, technology management, and engineering technology related programs (28-3-0). On February 28, 2007, at an all faculty meeting, the details of which programs would go into which of the new departments was discussed and decided, as well as proposed names for the new departments. All these

individual items were approved by strong majorities. It was decided to submit the entire package to the faculty for an up-or-down vote. The package was approved by 2/3 of the eligible voting faculty.

The faculty has decided to not put forth requests for altering the course prefixes at this time because further work is ongoing to negotiate combining some courses and eliminating some redundant courses caused by the reshuffling of programs into new department structures.

**COLLEGE OF NURSING, HEALTH, AND HUMAN SERVICES: Recreation and Sport Management** 

RCSM 496 Recreation and Sport Perspective—3 hours. This is a capstone course in General Education for Recreation and Sport Management students. This is an interdisciplinary offering focusing on the theories and practices taught in the various recreation and sport management discipline(s). Students will integrate the foundation and functional areas of the various RCSM discipline(s) and synthesis their RCSM education with their Liberal Studies experience. Prerequisites: A minimum of at least 78 credit hours, including all Basic Studies and seven of the nine Liberal Studies courses. See the General Education section of the *Catalog* for a complete description of the capstone requirement. General Education Credits [GE2000: Capstone Course]

Preferred effective term: Spring 2008

#### **COLLEGE OF ARTS AND SCIENCES: History**

HIST 356 Colonialism and Nationalism in Southeast Asia—3 hours. A comparative study of the establishment of colonial rule and the subsequent rise of nationalist movements in Southeast Asia between c. 1750 and c. 1950. Special attention will be focused on Indonesia, Vietnam, the Philippines, Thailand, Myanmar (Burma), and Malaysia. General Education Credits [GE2000: Historical Studies] Change title, description, and remove from General Education Program to:

**HIST 356 Modern Asian History**—3 hours. This course provides an overview of the history of Asia since 1500, when the nations of Asia developed toward their modern geographical, political, economic, and cultural forms.

#### **Brief Summary:**

When the Dance Minor was revised in 2005 the listing of the "Skill Proficiences" included four uses of the word "or". The inclusion of these words led to confusion and misinterpretation. Students are allowed to take any of the listed courses but the "or" terms suggest that they are only allowed to take one course within each of a set of two courses. The Department of Physical Education would like to remove these terms to provide clarity to the Skill Proficiences. There is no change in program hours or course requirements.
