**COLLEGE OF EDUCATION: Elementary, Early, and Special Education** 

**ELED 220 Integrated Curriculum for Young Children in Pre-Kindergarten Setting—**3 hours.

This course focuses on enhancing teacher candidates' pedagogical content knowledge and skills in planning integrated curriculum for young children three to six years of age with an emphasis on developmentally appropriate and culturally relevant teaching at pre-kindergarten settings. Field experience in a pre-kindergarten setting is required.

Preferred effective term: Fall 2008

**ELED 425 Early Intervention for Infants and Toddlers with Development Delay**—3 hours. This course connects learning theories to real-life situation and assists students in the planning and implementation of early intervention strategies for infants (zero-three) and young children with special needs. Field experience in infant toddler programs, early intervention, or early childhood special education settings is required. Prerequisite: 110.

Preferred effective term: Fall 2008

# **COURSE REVISIONS**

**COLLEGE OF EDUCATION: Elementary, Early, and Special Education** 

**ELED 110 Foundations of Early Childhood Education**—3 hours. This course is designed to provide an understanding of the role of the early childhood educator, to develop skills in observing and working with young children, to develop an awareness of the various types of programs serving young children, and to aid the student in developing a professional commitment to the field of study. The goals will be achieved through both observation and seminar sessions. Prerequisites: admission to the early childhood education major and passing the PRAXIS test.

**ELED 432 Early Childhood: Teaching Within a Diverse Society**—3 hours. This course introduces the conceptual frameworks of multicultural teaching and reviews the current research and practices relevant to teaching-learning solutions. Prerequisite: admission to BCP-I.

#### **Brief Summary:**

Add Art History as a Concentration in the BA/BS Studio major. This action is undertaken based on the results of program prioritization. This proposal also renames the emphases currently in the major as concentrations in order to facilitate their tracking in Banner.

#### **Student Learning:**

The change from a major to an emphasis in art history begin with Program Prioritization. Art history was targeted as a major that graduated fewer than ten students per year, which was one of the stipulations set forth by the Program Prioritization Task Force. Though occasionally art history classes were canceled due to low enrollment, enrollments in art history classes were not the problem. Additionally, because art history is required for accreditation of the Department of Art by NASAD, the elimination of the art history major gained no monetary savings to the university in the form of faculty salaries, since faculty had to be retained to teach art history courses. In April 2007, the art historians (Cavanaugh, Smithers, and Mayer) were encouraged to vote to essentially eliminate the art history major, and we did so with regret. The art history major in the BA track was therefore changed to an emphasis area in the BS track.

The bachelor of art/bachelor of science degree with a studio concentration is designed for the student who desires a more general education, or a second major. The total studio credit hour requirements are fewer, permitting a larger number of elective credits. This degree is designed for those who might wish subsequently to pursue the master of science or master of arts, or possibly master of fine arts degrees.

Requirements (30 hours): 18 hours of the core curriculum; ARTH 371—3 hrs.; an additional 6 hours of art history; ARTP 499—3 hrs.; and completion of a concentration, listed below. Interdisciplinary study in studio art may also be earned under the direction of a faculty advisor by combining courses in different studio concentrations.

Assessment Information: Students with a concentration in studio in the their last semester shall present a representative example of their work (one-two pieces) in an approved gallery setting. The work presented will be evaluated by the studio faculty of the students' area of Concentration and will be photographically documented. Students with a Concentration in Art History will submit a paper.

- 1. Complete the course work for two established minors, with a minimum of 9 hours in each minor taken at the 300/400 level and no fewer than 21 hours total from both minors taken at the 300/400 level. At least one of the minors must be from the College of Arts and Sciences.
- 2. Complete a special configuration of courses proposed by the student and developed in consultation with a faculty advisor from a department in which the course work will be concentrated. No more than 24 semester hours of course work toward the concentration may be taken from outside the College of Arts and Sciences or from a specific discipline.
- 3. Complete a combination of one and two.

#### **Other Requirements:**

#### **Brief Summary:**

Three substantive changes are proposed:

- 1. Due to reorganization in the College of Technology and the subsequent changing course prefixes it is necessary to update the catalog appropriately.
- 2. The Automotive Technology Management (ATM) faculty propose to change the math requirement from MATH 115 to MATH 111 or MATH 115 or higher. Effective in the Fall of 2006 the ATM program changed from MATH 111 to MATH 115 in an attempt to improve student's performance in IMT 215 Graphic Analysis (now MET 215), which is based upon solving technological "word" problems using elements of algebra, geometry, trigonometry, and statistics. Graphic Analysis has since been improved to include more asynchronous instruction in the basic elements of math and problem solving. Thus the original need to require MATH 115 is no longer valid. The combination of MATH 111 and IMT 215 (now MET 215) is an approved QLOC substitution. Transfer students seldom have credit for MATH 115. Students in the ATM program are required to take MET (IMT) 215 Graphic Analysis. After further review the ATM faculty find that MATH 111 and MET 215 is the practical math preparation for ATM majors.
- 3. In addition to the prefix change and the change in MATH requirement, it is proposed that a degree completion transfer program option be added in the catalog, similar to the Industrial Technology Management degree (approved in May 2007) to articulate with regionally accredited associate of science and regionally accredited associate of applied science automotive service degree programs which are also accredited by the National Automotive Technicians Education Foundation (NATEF). The combination of both accreditations, regional and NATEF, ensure a standard level of competence with regard to academic rigor and automotive technical content that satisfies ISU's interests and ultimately allows for such a robust degree completion program. The College Blue Book lists over 538 institutions across the United States with two year automotive service programs. The vast majority are accredited both regionally and by NATEF. With such a degree completion option the need for cumbersome articulation agreements with each individual institution that meets the accreditation standards is eliminated. In addition, this degree completion option can be easily marketed to two-year graduates across the U.S., raising the ATM program to a level of national recognition. Although this degree completion option is not yet deliverable completely at a distance, alternative modes of instruction are being explored which will make the degree program more amenable to distance students.

The Automotive Technology Management Program Advisory Committee has discussed such a degree completion program over the last four meetings spanning two years. All comments were positive and helpful, building the appropriate course structure for those students transferring to ISU with a degree in hand. Automotive faculty members and administrators from IVY Tech and Vincennes were represented on the advisory committee at each of the four meetings. It was also noted that this program would allow them to encourage students to complete their degrees at the two-year level, while concurrently encouraging them to transfer on to ISU.

## **Student Learning:**

The ATM program is accredited by the National Association of Industrial Technology (NAIT). The accreditation standards have been carefully reviewed and the changes proposed will not adversely affect accreditation.

It is anticipated that the proposed addition of a degree completion option will encourage more students to transfer to the ATM program at ISU, thus increasing the number of graduates and increasing industry awareness, which will positively impact program effectiveness.

## **COLLEGE OF TECHNOLOGY: Technology Management**

Manufacturing Technology Minor (19 semester hours) CIP Code: 150613 Major Code: E233

#### **Brief Summary:**

Over the past few years the Manufacturing program faculty have been working to combine two programs, Manufacturing Technology and Computer Integrated Manufacturing. Recently the recommendation of the Program Prioritization Task Force was to reorganize these two programs into one program. Faculty in the program are making changes they feel will strengthen the program. Several changes were made to the major which also affect the minor. The changes are to remove some courses from the minor and add other courses to the program. All of the cosurses are existing courses. Specifically, we propose to eliminate these courses from the program: MFG 372 and TMGT 477.

Academic Notes 12 March 24, 2008

We propose to add the following course to the program: MFG 225. The course MCT 270 is changing to ECT 280. In addition, we propose to change the title and/or description of three courses: MFG 370, MFG 371, and TMGT 374.

The faculty believe this will better prepare students with a minor in Advanced Manufacturing Management.

### **Student Learning:**

The proposed changes will achieve several goals. It will allow us better articulation opportunities with two-year schools for those students who may want this minor. It includes content input from our industrial advisory board that will create a program that will better serve students and employers. Student outcomes assessment from alumni surveys, internship and employer surveys have identified necessary skills for a successful functioning professional in manufacturing management. Our 2004 reaccreditation by NAIT of both programs suggested some changes that would increase student learning and program effectiveness.

Using our current structure to support a licensure program does not strain university resources but does allow flexibility for the student who seeks only the license.

The "assessment" that necessitates this proposal is an outcome of student migration in and out of the Master of Science in Educational Technology with specialization in Library Media program. Some students seek admission into the MS in Educational Technology program with the intention of only completing the courses required for licensure. Once the courses are completed, the student is actually eligible for the license so the student achieves the desired outcome (licensure) while appearing on our rolls as program non-completers. Conversely, some students are admitted as non-degree, post-licensure only. Many complete the collection of courses and subsequently decide to complete the MS in Educational Technology not understanding that only a limited number of courses completed for the license can actually be applied to the MS by virtue of Graduate School rules regarding transfer of non-degree credit hours. Obviously, the lack of clarity about this circumstance resulting from not having an approved and appropriately advertised licensure program often leads to confusion and frustration among the students, as well as the faculty involved in advisement.

This program has been in existence for at least 5 years as a collection of courses that lead to the license, but was never formally proposed as a non-degree program, such that it would appear in the catalog and that student head counts could be tracked through Banner. Program prioritization did not include this program because it did not in reality "exist" and student head count could not be tracked.
