5. Reports

A. Associate Deans' Reports

S. Powers reported on the NCATE previsit, which was organizational and logistical in nature. This meeting went well. Team members were complimentary and excited to talk with faculty. Issues of what went wrong and where we have gone from there were discussed with team members. We have come a significant distance. Shared assessment for advanced programs is an impressive accomplishment. This may be worthy of national presentation. The agenda for the focused visit is shared and discussed. An overview of the unit will be given on Sunday of the visit. Monday they will be on campus. They will talk with current students in the afternoon. They will be looking at work samples for elementary and secondary education. Teachers will talk to the team as well on Monday. It is critical that we have full representation at the TEC meeting with the team. Copies of the report and exhibits will be shared with TEC members. Members should read these and share them with other faculty. A list of all the assessments, where they are used, when they were created, and when they were implemented as well as a copy of the assessment form will be created and distributed.

A spot at the 2008 accreditation program in Arlington VA has been reserved. It would be fitting for someone interested in chairing TEC in the future to attend. This conference will take place April 3-6, 2008.

Lilly fellows are coming again. A group of six will be here at the end of January.

R. Libler reported on work with PDS partners and implementation of actions stemming from Project Pre. She is pleased to see the changes occurring in all teacher education programs that are implementing these changes. Revised program proposals will be forthcoming from elementary education. Secondary education has a program retreat in January. All are welcome to attend.

A workshop is being developed in response to a request from Vigo County to have more individual certified to mentor other teachers. There are 65 individuals interested in taking such a workshop, which is more than anticipated. 50 people will be certified to be mentors from this hybrid format workshop.

B. ESS Report.

J. Sheese discussed and provided data on petitions. A breakdown of the type of petition and frequency was provided. Common trends are identified.

Departments have been changing policy when appropriate to address these common trends.

Praxis 1 and 2 scores are back. Information on these scores will be distributed to TEC within the next week.
