1. Call to Order: R. Hinshaw called the meeting to order at 3:35 p.m.

- 2. Approval of Minutes for October 18, 2011: C. Becker moved to approve minutes and C. Ball seconded. No discussion. Minutes were approved (12-0-0).
- 3. Old Business: None
- 4. New Business:
 - a) Voting and TEC Procedures

Parliamentarian C. Becker discussed TEC procedures after proposals are voted upon. Approved proposals move on to the next level (even if slight typographical errors need correcting). Unapproved proposals have 2 paths: a) if changes are substantial, then reworked by proposing department for action at future TEC regular meeting; b) if changes are substantial, but there is a tight timeline, then reworked by proposing department for action by TEC Executive Committee outside of regular meetings.

- b) <u>Update from UAS Committee Steve Gruenert</u>
 - The UAS Committee met on Nov. 10, 2011, to continue ongoing analysis of Assessment Day data. The committee has also worked on the conceptual statement for the UAS Committee: what it is and what it does: to articulate the work of the UAS Committee. The UAS Committee is continuing to develop methods to measure BCOE candidates' impact in the P-12 environment. The UAS committee meets each Thursday before TEC regular meetings.
- c) Program Proposal CAS Language Studies Teaching Major
 C. Becker moved to approve the program proposal, T. Balch seconded. Guest Leslie
 Barratt (LLL) discussed the nature of the change: GPA requirement changed from 2.5 to

- 2.75 to encourage greater content knowledge acquisition from majors with the intent of improving Praxis II test scores. Proposal approved (13-0-0)
- 5. Dean's/Associate Dean's Report-Denise Collins: 1) Discussion of future action item regarding moving CIMT 301/2 from its current time block (12-2 pm, MWF) to 8-10 am, MWF, to facilitate more effective and efficient Early Field Placements in area middle schools. The change would make it easier to schedule time in classrooms as well as "block" the sections of the courses together providing more cohesion to the program; 2) Dean Balch, Sue Kiger, and Diana Quatroche are away from campus presenting at the "Teachers for a New Era" conference; 3) "Teachers for Tomorrow" event today in BCOE roughly 30 high school students entering teacher education programs at ISU on campus meeting faculty, attending classes, etc . . . ; 4) Thank you to TEC and UAS for ongoing discussion of the BCOE Conceptual Framework at next TEC regular meeting the new graphic will be revealed.
- 6. ESS Report: No report; J. Sheese attending a student teacher meeting; D. Collins noted that ESS is advising and registering students currently as well as completing many reporting responsibilities (Title 2, etc...)
- 7. Adjournment: The meeting was adjourned by R. Hinshaw at 3:56 pm.
