Dear Dr. Bradley:

The **Indiana State University Physician Assistant Program** has been granted **Accreditation – Continued** status by the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA). This decision is based on the program application and appendices, the report of the site visit team, the program response and its accreditation history.

The ARC-PA noted **eight (8)** areas of noncompliance with the *Standards*. Please see the companion Word document for the complete report and requested response.

The program is required to submit an acceptable response no later than **November 1, 2013 (SCPE), July 1, 2014 (citations) and October 1, 2015 (additional report)**. Failure to do so may result in the scheduling of a Focused Visit and/or reconsideration of the program's accreditation status.

The approximate date for the next validation review of the program by the ARC-PA will be **September 2020**. The review date is contingent upon continued compliance with the *Standards* and ARC-PA policy. The ARC-PA reserves the right to adjust the date or schedule.

The program will be contacted by the ARC-PA in advance of that review regarding details of the application, reports and site visit.

Please note that the program is approved to accept up to a class size of **30**. The ARC-PA will not consider an increase in class size or expansion to a distant campus from any accredited program until the program has maintained five years of continued accreditation without an adverse accreditation status.


